### **JÉRÔME STOLL IS APPOINTED LEADER OF THE AMERICAS REGION MANAGEMENT COMMITTEE FROM FEBRUARY 1, 2009**

On February 1, Jérôme Stoll will replace Thierry Moulonguet as Leader of the Americas Region Management Committee. Mr Moulonguet will remain Executive Vice President and Chief Financial Officer.

Jérôme Stoll remains Senior Vice President for Mercosur and CEO of Renault do Brasil. He reports to Patrick Pélata, Chief Operating Officer.

The Americas region includes Central and South America.

*Jérôme Stoll was born on March 8, 1954 in Tunis, Tunisia. After working for Renault VI from 1980 to 1983, he joined the general management of Berliet Nigeria, a subsidiary of RVI (1983-1987). He joined Renault's finance division in 1987 and became the Senior Vice President of Finance and Administration at Renault Automation in 1989. He was appointed Vice President of industrial purchasing in 1995 and Vice President, powertrain purchasing in 1998. He was appointed CEO of Renault Samsung Motors when the company was bought out by Renault in September 2000. On May 1, 2006, he became Senior Vice President for Mercosur, was appointed CEO of Renault do Brasil and became a member of Renault's Management Committee. He reports to Patrick Pélata, Chief Operating officer. Jérôme Stoll is a graduate of the Ecole Supérieure de Commerce de Paris (ESCP) and the Centre de Perfectionnement aux Affaires (CPA).*

*Born in 1951, Thierry Moulonguet started his career in 1976 at the Ministry of the Economy and Finance and remained in the public sector until 1991. He joined Renault in February 1991 and took charge of the Group's financial relations, before being appointed Director of Investment Control in 1996. Following the creation of the Renault-Nissan Alliance, he left for Japan and joined Nissan Motor as Senior Vice President, Finance. In 2000, he was appointed Executive Vice President, Chief Financial Officer of Nissan. In September 2003, he joined Renault's management committee as advisor to the Chairman, before becoming Executive Vice President and Chief Financial Officer in January 2004 and joining the Executive Committee of the Renault Group. He has been Leader of the Americas Region since February 2006. He reports to the President of Renault, Carlos Ghosn. Thierry Moulonguet is a graduate of the Ecole Nationale d'Administration.*
