### RENAULT Management Committee Nominations

As of September 1st 2008, five new members are appointed to Renault's Management Committee:

- **Christian Mardrus**, Senior Vice President, Information Systems

**Bruno Ancelin**, born on December 11, 1957, holds a degree in Civil Engineering from Ecole des Mines de Paris, and he is Chief Engineer of the Corps des Mines. He joined Renault in 1982, in the Research Department. In 1987, he joined the Manufacturing Department at the Mans plant, first as Manager in the Transmission Department, then as the Manufacturing Process Manager. In 1992, he became Industrial Strategy Manager at the Manufacturing Technologies Department. In 1996, he joined the Flins plant where he became Deputy Director in charge of manufacturing. In 1999, he became Supply Chain Director, and in April 2006, Program Director for Mégane, Scénic and Koleos.

**Bernard Cambier**, born on October 15, 1953, holds a Masters degree in private law. He joined Renault in 1979 and held a number of different positions at the DIAC. He was named Branch Director in 1990, regional director for northern and eastern France in 1992, General Manager of Renault Switzerland SA in 1994 and head of the multi-brand used car project in 1997. From 1999 to 2001, he was Sales and Marketing Director for the Upper Range. He became Vice President, Corporate Sales Division in September 2001. He was appointed Vice President, Parts and Accessories on January 1, 2005.

**Christian Husson**, born on May 21, 1950, holds a Masters degree in law. He began his career in 1975 at the DIAC as Assistant Manager of Consumer Affairs. In 1978, he joined Renault's Legal Department. From 1983 to 1986, he was detached to American Motors. From 1986 to 1995, he held a number of different positions in Renault's Legal Department and became Vice President, Legal Department and Secretary of the Board in 1995.

**Nadine Leclair**, born on August 27, 1957, holds an engineering degree from Ecole Centrale in Lyon. She began her career at Sligos as a research engineer before joining Renault in 1984 as a CAD engineer. Her first experience in bodywork engineering was on the Safrane project in 1989, then on the Mégane 1 project. She was appointed Manager of Body-in-white Engineering in 1999, a position she held until 2005, when she became Technical Manager for the Mégane Range. On January 2, 2008, Nadine Leclair became Vice President, Vehicle Engineering Development.

**Christian Mardrus**, born on March 18, 1959, holds engineering degrees from Ecole Polytechnique and Corps Interministériel des Télécommunications in Paris. He began his career at the French Telecommunications Authority, then worked at Peat Marwick Consultants from 1986 to 1991. Between 1991 and 1999, he held a number of positions within the Otis group. He joined Renault in November 1999 as Director of Sales Information Systems before being appointed Vice President, Services at the Sales & Marketing Department in February 2002 and Director of the French Sales Network in July 2004. He has been Vice President, Information Systems since July 1, 2006.
